A Demographic Analysis of Lay Employees in The Church Pension Fund's Retirement Plans

What's in This Report?

- This report provides an overview of demographic, geographic, and compensation differences of current, domestic lay employees enrolled in The Episcopal Church Lay Employees' Defined Contribution Retirement Plan (Lay DC Plan) and The Episcopal Church Lay Employees' Defined Benefit Retirement Plan (Lay DB Plan) sponsored by The Church Pension Fund (CPF).
- The compensation figures presented in this report are medians.
- Only lay employees who work more than 1,000 annual scheduled hours are included, a total of 13,347 employees.
- For the purposes of this report, individuals who have between 1,000 and 1,500 annual scheduled hours ("Below 1,500") are considered part time. Individuals with 1,500 or more annual scheduled hours ("1,500 and up") are considered full time.
- Only 40% of position data is known due to factors such as selection of "Other Lay Position" or blank entries.
- We do not collect data on lay employee race or ethnicity.

What to Consider When Reviewing This Report


This report provides a range of statistics about lay employees enrolled in retirement plans sponsored by CPF. While every lay employee participating in CPF's retirement plans is covered in this report, we recognize that the data is not as detailed as that contained in the Clergy Compensation Report because we do not have exact position titles for the majority of employees. This means that making exact compensation comparisons between employees in similar positions and employment situations is not feasible as of this moment. We hope, as employers provide more data on employees positions, to be able to procure more comprehensive compensation data.

Protecting Privacy


CPG preserves the anonymity of individuals behind the data. One of the many ways this is done is by reporting the median compensation for a demographic group only if it contains at least five individuals.





Years Employed in The Episcopal Church




Annual Scheduled Hours by Gender



Median Compensation by Annual Scheduled Hours




Most Prevalent Positions








Median Compensation


Gender Identity*



Years Employed in The Episcopal Church




Most Prevalent Positions

Below 1,500






Employer Type


- School: Daycare, seminary, university
