#### 2020 Disability Insurance Enrollment Now Under Way

Dear Employer,

As previously announced, Zurich American Life Insurance Company (Zurich), a New York domestic life insurance company, will become the insurer for the group short-term disability (STD) and long-term disability (LTD) insurance policies effective January 1, 2020. If you wish to continue offering this disability coverage to your employees, please review the disability coverage options, and make an election no later than October 25, 2019.

The enclosed materials provide details designed to help you understand the disability insurance options. You may offer either employer-paid *or* employee-paid (voluntary) disability coverage. You may elect to offer both STD and LTD policies (one policy for each type) or select just a single STD or LTD policy. (Remember, active clergy participating in The Church Pension Fund Clergy Pension Plan already receive both STD and LTD benefits.)

# Disability Coverage Cost Summary

Details your current STD and/or LTD coverage cost in comparison to each of the new disability coverage options. The customized tables also identify the new Zurich options that align most closely with your current disability coverage.

If you do not elect an option, you will be enrolled automatically in the default disability options identified in the Disability Coverage Cost Summary.

### **Next Steps and Key Dates**

- Make your online selections no later than October 25, 2019.
- If you elect to offer employee-paid (voluntary) disability coverage, your employees will need to make an
  enrollment decision between November 1 and 29, 2019.
- The effective date of coverage is January 1, 2020.
