Dear Diocesan Administrator:

The Episcopal Church Annual (The Red Book) serves as an essential resource for many across the Church. Its accuracy depends on timely updates from institutions like yours. To fulfill the canonical requirement to report clergy positions—whether part-time, retired, non-stipendiary, or otherwise—it is vital that the information in My Admin Portal (MAP) be accurate and current.

The data in The Red Book is pulled directly from Church Pension Group's systems. By reviewing and updating your institutions in MAP, you help ensure that this valuable resource reflects accurate and complete information. I ask that you review and update MAP to include the currently active Institution Administrators for each of your institutions by January 6, 2026.

Here is how your input will serve as a critical first step in promoting enhanced information-sharing:

- We use the Institution Administrators listings to contact your institutions about the 2026 edition of The Red Book. Your updated listings enable our Church Publishing Incorporated team to reach the correct person at each institution who can verify the accuracy of its content.
- We also use the information you furnish for Institution Administrators to ensure that CPG resources reach their intended audience. This includes invitations to conferences and webinars and updates through emails and newsletters.

Please take a moment today to review, update, and/or complete the information for your diocese:

- From the landing page in MAP, click the "People" tab.
- Click "View Institution Administrators" and select an institution to review admins.
- Click "Add Administrator" to add an administrator or "Remove" to remove an administrator's access.

Clergy, non-stipendiary priests, and deacons may also enter their personal information in <u>MyCPG Accounts</u>.

I know your time is valuable, and I thank you in advance for your attention to this task.
