Mary Kate Wold CEO and President Church Pension Group

As Chief Executive Officer and President of the Church Pension Group (CPG), Mary Kate Wold leads a \$13 billion financial services enterprise that provides retirement, health, life insurance, property and casualty insurance, and other products and services to the Episcopal Church. She also serves as a member of the Board of Trustees of The Church Pension Fund, CPG's governing body.

Mary Kate has served in a variety of leadership positions in the corporate, legal, and government sectors. Prior to joining CPG, she was a senior finance executive and principal corporate officer of Wyeth, one of the world's largest pharmaceutical companies. Before embarking on her corporate career, she was a partner and chaired the tax practice group of Shearman & Sterling, a leading global law firm. Earlier in her career, she served in the Office of Tax Policy of the United States Department of the Treasury.

She chairs the board of the Church Benefits Association, a national association of faith-based benefits organizations, and she serves on the vestry of Trinity Church Wall Street and on its investment committee, which oversees the institution's \$5 billion real estate and securities portfolio. She is a former director and chair of a publicly traded medical device company. Mary Kate's professional affiliations include membership in the Women's Forum of New York and Women Corporate Directors.

Mary Kate spent her childhood in Bottineau, North Dakota, a small rural community on the Canadian border. She graduated from Hamline University in St. Paul, Minnesota, *summa cum laude* with a BA in English and Theater, and was elected a member of Phi Beta Kappa. She later graduated *cum laude* from the University of Michigan Law School.

Dave Chen Principal and Chairman Equilibrium

Dave Chen is Principal and Chairman of Equilibrium. He leads the firm's strategy and product development process. His primary duty is to ensure the growth of the firm and team while continuing its culture and shared values. He serves on Equilibrium's Board of Directors.

Dave's passion and commitment to sustainability is a result of his work in venture capital, regional economic development, and climate change policy. In 2007, he saw sustainability trends that were reshaping major commodity sectors, creating an economic value shift and an opportunity for market advantage. He formed Equilibrium to be a global leader in sustainability-driven asset management for institutional investors that delivered both sustainable alpha and intentional positive impact on our community and environment.

Previously, he was a general partner at OVP Venture Partners (2000–2007). He served on the board of @mobile prior to its acquisition by Software.com and served on the board of HNC Software until it was merged with FICO in 2002 (NASDAQ:HNCS, now NYSE:FIC). Dave founded GeoTrust (acquired by VeriSign 2006) and The Ascent Group and has also held roles at Mentor Graphics, McKinsey & Company, and Solectron.

He has a BA in biology from the University of California, Berkeley, and an MBA from the Kellogg School of Management at Northwestern University. He is co-owner of Patton Valley Vineyards, committed to making the finest Oregon pinot noir based on sustainable vineyard farming practices.



The Rev. Kirsten Snow Spalding Senior Program Director, California Ceres

The Rev. Kirsten Snow Spalding serves as Senior Program Director, California for Ceres, a sustainability nonprofit organization working with the world's most influential investors and companies to build leadership and drive sustainability solutions throughout the economy. She leads Ceres' policy, corporate, and investment initiatives on the West Coast.

Prior to joining Ceres, she served as Chief Deputy Treasurer under California Treasurer Phil Angelides and Director of the Treasurer's environmental financing authorities. Prior to her government service, Kirsten worked in the labor movement as Chief of Staff for the California Labor Federation, AFL-CIO. With the California Sierra Club and the Ella Baker Center, Kirsten co-founded the California Apollo Alliance. For six years, she chaired the Center for Labor Research and Education at University of California, Berkeley, and taught at Boalt Hall School of Law. As a lawyer with the firm of Beeson, Tayer, & Bodine, she represented unions and their pension plans.

In her early career, she worked as a community and cultural organizer in Durban, South Africa. She holds a BA from Yale College in music, a JD from Hastings College of Law, and an MDiv from Church Divinity School of the Pacific. She is Rector, Episcopal Church of the Nativity, San Rafael, a wife, and the mother of two teenage sons.
